# ACTIVITY REPORT 2004-2006

#### **YEAR 2004**

In 2004, the priority of the UEF was informing and educating the citizens about the challenges the EU is facing: the accession of ten new countries, the election of the European Parliament, the appointment of the new European Commission, the Constitutional process and the achievement of the draft Treaty establishing a Constitution for Europe.

In light of the Constitutional process in 2004, UEF carried out a transnational campaign for the European Constitution, giving the priority to informing citizens about the final steps of the approval of the draft Treaty and to explain the achievements of the latter.

#### **YEAR 2005**

The 2005 UEF priorities were all related to the promotion of the Constitutional Treaty, through the organisation of a Transnational Campaign for a European Constitution, an information campaign about the draft Constitution, a debate with European citizens and politicians, and a ratification campaign for the Constitutional Treaty.

2005 being the year of the EU's further integration and enlargement, the UEF has especially focused on involving and acquiring new member organisations and has succeeded in building up new organisations of the UEF in Sweden, Cyprus and Slovenia. The aim was to build a bridge between old and new member states.

Of course, the activities took a radical new orientation after the French and Dutch Referenda. We therefore decided to organise a series of European Citizens Conventions, in order to take the constitutional process back to the citizens of Europe and discuss the notion of federalism and the new expectations from Europe. The first Convention took place in Genoa on 3-4 December 2005: a European Manifesto was drafted and adopted, calling on member states to continue the ratification of the European Constitution.

#### **YEAR 2006**

In 2006 the priorities of the UEF-Supranational had to be adapted to the totally changed political situation in the EU after the NO-referenda: new activities run parallel to the "usual" activities of the UEF.

Beginning with the new Commission late 2004, the EU-institutions stressed the importance of the Civil Society's support for the EU and the lack of a political communication within the EU. Therefore, the "Plan D, for Dialogue, Debate and Democracy" was launched in October 2005, and in February 2006 the "White Paper on a European Communication Policy" was adopted. Moreover the EP started with the organisation of interparliamentary and citizens' fora.

Therefore the UEF Secretariat lay one additional focus on the accomplishment of these very promising and well-intentioned programs; unfortunately, finally only little resources were provided and it all turned out to be more bureaucratic than expected. However, these programs can not only be seen as the first step towards the improvement of the public support for the EU project, but they also provide the UEF a strong opportunity to be involved in these citizens motivating/informing activities, serving as a basis for our political aim directed to the creation of a supranational, finally federal Political European Union.

Another important priority for 2006 is the improvement of our organisation and network. For instance, the MEP-breakfast serves as an informal meeting point with the MEPs with a special experience and interest in UEF (Jo Leinen etc.). It is an opportunity to exchange political issues, get advice, ideas and information. Of primary importance is also the newly created informal group of young friends of the UEF, called "Think-Tank," which involves former JEF-activists, who support the UEF Secretariat with the preparation of comments, the planning of events, the exchange of ideas, and the managing of the contacts with younger people, thus supplementing "Group Europe".

Moreover, the deepening of cooperation with JEF and with the EMI has provided synergies: this was especially realised through cooperation within the framework of the Plan D call for proposals to which the three organisations applied together.

The seminar took place at a time of important changes for the EU; the participants mainly discussed the outcome of the European elections and challenges for the EU, in particular the enlargement and the adoption of the draft Constitution.
- *International Seminar on Federalism & International Democracy* (4-9 September 2004, Ventotene). Young people from all over Europe gathered to debate the present end future challenges for federalism and democracy in Europe.
- *Ratification Campaign Meeting with NGOs* (9 October 2004, Brussels). Members of the UEF, JEF, the EMI and other European NGOs gathered to discuss a pro-European ratification campaign.

- **Documentary on the Convention** (2004). In order to introduce debates about the European Constitution and its ratification, the UEF supranational Secretariat provided the regional and national constituent organisations with a one-hour VHS videotape, available in English and French.
- *UEF Website*. Our website <a href="www.federaleurope.org">www.federaleurope.org</a> has been growing constantly and it is our main source of contact with our members and European citizens. It includes information about the UEF and its history, news about its activities, links to other organisations and a press section, with the Newsletters and Press Releases. It is also the place where all documents emanating from our meetings are posted. It is available in three languages: English, French and German.
- *UEF Newsletter*. The monthly UEF Newsletter is accessible for free on our website and remains the main source of information about UEF activities. It is the link between the Secretariat and the individual members in each EU member state and the candidate states.
- *UEF Press releases*. The UEF has published 7 Press releases in 2005 to ensure that European citizens are aware of the activities being organised by pro-federalist forces in Europe today. Press releases are sent to European and national press agencies and newspapers, and then posted on our website, where everybody can consult them at anytime.

- *The Federalist Debate*. These "Papers for federalists in Europe and the World" are published 3 times a year and are promoted by the UEF, JEF and WFM.
- *Group of visitors to the EP* (2 December 2004, Brussels). The UEF organised a visit to the European Parliament for a group of about 25 young Italians from the region of Rome.

#### Detailed description of the activities organised by the UEF in 2006:

#### **GRANT APPLICATIONS:**

- Application to the usual operational grant 2006, provided by the European Commissions Directorate-General for Education and Culture. This has been the first application since the UEF has lost its earmarking and fortunately, the amount requested has finally been approved in the first week of June.
- *Call for proposals of the EP*: the intention was to give support to EU-related public debates, conferences, seminars with the Civil Society. Unfortunately, the UEF application was not approved.
- *Plan D*: together with the European Movement International, JEF and other pro-European Civil Society organisations, the UEF replied to Commissioner Wallström's call for proposals in the framework of Plan D. Several UEF sections answered to our call for cooperation. We hope to be informed on the Commission's decision soon, so that we can start extensive and harmonised programmes in as many UEF sections as possible.

At this occasion, the UEF handed over an appeal urging the European Parliament to re-launch the constitutional process.
- "Sound of Europe" (Salzburg, 26-27 January 2006). Friedhelm Frischenschlager, Secretary-General of the UEF, attended "Sound of Europe" on 26-27 January in Salzburg as representative of the UEF.

EU Commissioner for Communication Margot Wallström presented the White Paper during a debate which gathered around 500 participants, which consisted of representatives of the regions, NGOs, associations, think-tanks, European Institutions and the media. The heart of the event was the presentation of the White Paper, which was adopted on the same day by the European Commission.
