- J. Rising tensions in Ukraine and escalation made by Russian armed forces against Ukrainian forces close to the front-line and to all Ukraine,
- K. The growing disproportionate military campaign launched against Gaza strip by Israeli Military Forces (IDF) after the cease-fire expiration mediated by United States, Egypt and Qatar (and supported by Resolution 2735 of the United Nations Security Council), and causing severe causalities among civilian population in Gaza, questioning the respect of International Humanitarian Law and Human Rights customary Law.


