

UEF Finland - Call for participants to attend the Turku Europe Forum (27 - 29 August 2025)

Introduction

Organised since 2018, the Turku Europe Forum is an annual event dedicated to debates on EU topics. Held at the City Theatre of Turku, Finland, the event is set to feature high-profile speakers: among others, the programme features Henna Virkkunen, Executive Vice-President of the European Commission and Petteri Orpo, Prime Minister of Finland. The Turku Europe Forum takes place in Finnish and English, with simultaneous interpretation to English available. In 2024, the event attracted 900 in-person participants, with over 4,400 viewers watching the sessions live online.

The 2025 Turku Europe Forum will take place on **27 - 29 August**. The initial programme of the event is available on the <u>Turku Europe Forum website</u>.

On 27 - 29 August, UEF Finland will organise three events:

- Public Debate event: "European security: a common defence and a federal response to the challenges of the 2020s?"
- Federalist Evening gathering at a river boat
- UEF Organisational development workshop for Nordic and Baltic countries

Invitation for international guests

We would like to invite the UEF and JEF sections from Nordic and Baltic countries to join us in Turku to attend the Europe Forum and to **organise capacity-building discussions on the development of UEF sections in the region**.

Our goal is to gather 1-2 activists from each section, for a total of ca. 10 international guests. The main goal of the event is to boost the organisational development of the federalist family in the Nordic-Baltic region, and to develop new ways to advocate for federalism in our countries. We encourage partner sections to nominate members who are engaged in a leading role in their section, and who are committed to cooperation between different national sections in the federalist family.



We would appreciate sections' responses, confirming the participants nominated by each section, by **Saturday 12 July**. After this date, UEF Finland and UEF Europe may extend the invitation to other sections beyond the Nordic-Baltic region, until the target number of 10 international participants is reached.

How to get to Turku?



Located at the Southwestern corner of Finland, Turku can be reached by boat, by airplane, or by road or rail from Helsinki:

- Boat: Tallink and Silja Line have regular connections between Stockholm and Turku.
- Plane: Turku Airport has direct flights to Stockholm and Copenhagen (Scandinavian Airlines), and Riga (AirBaltic).
- Road/rail: From Helsinki, Turku can be reached by rail (VR) or by bus (Onnibus). The journey takes ca. 2.5 hours.

Where to stay in Turku?

Participants are invited to organise their own accommodation independently. There are several hotels in the Turku city centre, near the Turku City Theatre which serves as

the main venue of the Turku Europe Forum.



Participants may self-organise to stay in shared rooms. For the confirmed participants, UEF Finland will create a participants' WhatsApp group to help you contact other participants.

Some budget-friendly options in Turku include:

- Omena Hotels (https://www.omenahotels.com) is a budget, self-check-in hotel chain with two hotels in Turku, both within 15 minutes' walk from the Turku City Theatre: Humalistonkatu 7 and Kauppiaskatu 4
- S/S Bore (https://tai.fi/en/subsite/bore/accommodation/) is a ship that serves as a hostel. It is 30 minutes away from the Turku City Theatre by foot, and reachable within 15 minutes by bus.
